

# Sponsorship Agreement

This sponsorship agreement is between "ISC2 Eastern MA and ISC2 CT", the 'Organizer' and \_\_\_\_\_, the 'Sponsor'.

The Sponsor wishes to sponsor the Organizer and their event 'The Cybersecurity Practitioner Event' (CPE) to be held on a future date to be determined, in exchange for certain rights to be granted in connection with the organizer and its event:

The Cybersecurity Practitioner Event is an annual conference organized, led and facilitated by practitioners that brings together cybersecurity practitioners to share their expertise and network with their peers from all industries and sectors. Several sessions starting at 8:00 AM will address various aspects of tangible cybersecurity knowledge, skills and practices. We expect to host upwards of one hundred cybersecurity professionals from the northeast region (max. 400). Sectors represented include Government, Gaming, Insurance, Cybersecurity, Education, Healthcare, Financial Services, and others. **The 'CPE' will be held February 13th 2026 at Mohegan Sun Casino in Uncasville CT.**

## 1. GRANT OF RIGHTS

In exchange for the Sponsorship Fee, the sponsor will receive the following rights at the sponsored level in connection with the Organizer (Collectively, the 'Sponsorship Rights')

Costs: \$4,500 Involvement

- Table at the event in a less traffic area.
- Opportunity to provide company-branded swag (Sponsor provides own)

## II. **Silver Level:** The High Roller Ideal for: Sponsors who want a stronger presence and networking opportunities.

Costs: \$6,000

Involvement Includes:

- List will be provided to the email on this contract after the event for attendees that opted-in for vendor contact.
- Table at the event in moderate traffic area
- Opportunity to provide your company-branded items to attendees. (Sponsor provides own)
- Logo inclusion in event material
- Mention in opening and closing remarks.
- Sponsor Name on a specific activity (if available, breakfast or lunch) determined by organizer.

III. **Gold Level:** The Jackpot VIP Ideal for: Sponsors aiming for maximum visibility and prestige.

Costs: \$10,000

Involvement Includes:

- List will be provided to the email on this contract after the event for attendees that opted-in for vendor contact.
- Prime table at the event in a high traffic area.
- Opportunity to provide your company-branded items to attendees. (Sponsor provides own)
- Opportunity to deliver a 10 minute speaking session on the main stage at a time defined by the organizer.
- Top-tier logo placement and branding on all materials.
- Mention in opening and closing remarks
- Dedicated social media posts and top billing in all pre- and post-event communications.

2. Sponsorship Fee

In exchange for the Rights listed above, the Sponsor shall provide the Organizer a fee of the determined level as noted above in section one payable by check, bank transfer, or other negotiated means at the time of execution of this agreement. Sponsor shall add in additional costs to cover service and/or transfer fee if applied based on transfer method.

3. Duration

The duration of this agreement shall be for the period between the execution of this agreement and the end of the event. Sponsors are required to be fully set-up by 8:00 AM EST the day of the event. Sponsors are requested to not break down their booth until after 5:00 PM EST.

4. Termination

This agreement may be terminated:

- a) By either party on provision of written notice, with or without cause.
- b) By the Organizer due to unforeseen circumstances with refund of any sponsorship fees paid.
- c) By either party for a material breach of any provision of this agreement by the other party if the other party material breach is not remedied within 15 business days of receipt of written notice of the breach.
- d) By either party at any time and without prior notice, if the other party is convicted of any crime or offense, fails or refuses to comply with the written policies or reasonable directives of the other party, or is guilty of serious misconduct in connection with performance under this agreement.
- e) By the Sponsor, with or without cause, on written notice to the Organizer. However, the Sponsor shall forfeit any payment of the Sponsorship Fee or other monies already made to the Organizer.

5. Governing Law and Terms

The laws of the State of Connecticut govern this agreement (without giving effect to its conflicts of law principles). The Sponsor acknowledges and agrees that the Organizer shall not be held responsible or liable for any damages, losses, injuries, or other negative outcomes that may occur in connection with the Event or activity. This includes, but is not limited to, any financial losses, property damage, personal injuries, or reputational harm. The Sponsor assumes all risks associated with their participation. The Organizer has made reasonable efforts to ensure the safety and success of the event but cannot guarantee any specific outcomes. The Sponsor agrees to indemnify and hold harmless the Organizer, its employees, volunteers, and affiliates from any claims, demands, or legal actions arising from the Event or activity. Any disputes arising from this agreement shall be resolved through mediation or arbitration before pursuing legal action.

No warranty or guarantee outside this agreement is made by the Organizer.
